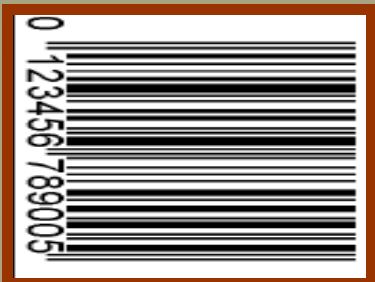

We entered May with \$3,734.94 in the bank account. We received \$75 in income from a tap handle sponsorship. Expenses totaled \$1,878.31, leaving us with an ending balance for March of \$1,931.63. The majority of the expenses were the costs for the bar reconstruction, with some additional club brew costs thrown in.

Speaking of the bar, we still have 7 taps available for sponsorship. For \$75, you can get your name engraved on a plate assigned to a tap. Your donation goes to cover hardware for that tap and the general construction of the bar. You can mail your check to me or see me at the June meeting.

We currently have 53 paid members, including 12 new members this year. If you haven't renewed your membership for 2010 yet, please send me a check or bring your dues to the July meeting.

Dues are \$25, plus another \$10 for each additional family member. Also, if you would like a paper copy of the Dregs mailed to you each month, add an additional \$5 for postage. If you'd like to renew by mail, please mail a check made out to "Strand Brewers Club" to me at 1008 Teri Ave, Torrance, CA 90503.

On the club tax status issue, I got our EIN reactivated, and reclassified us as a 501(c)(7) tax exempt organization. In a few weeks our number will be back in the system, and I will be able to file our federal return.

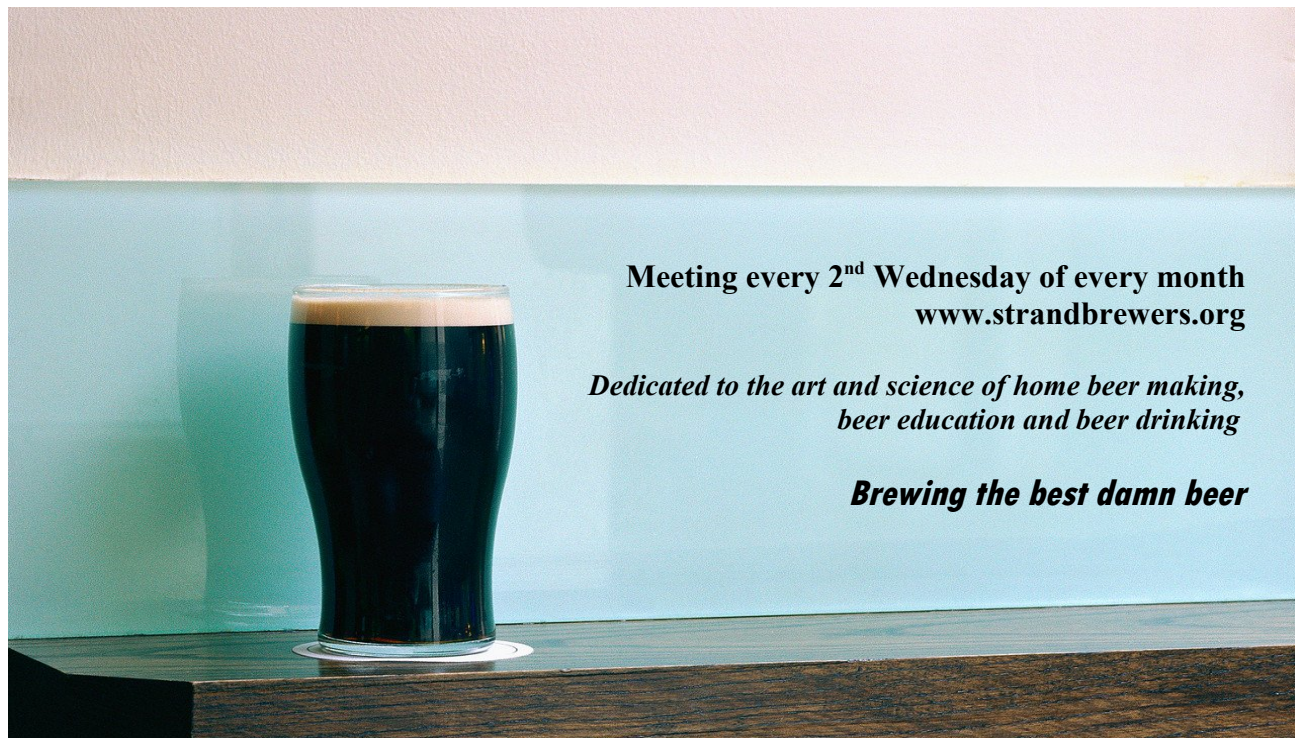
